Painful joints? Here's a few operations that might help

Hip replacement

Is a surgical procedure in which the damaged or worn parts of the hip are removed and replaced with a new artificial implant made out of metal and or ceramic, and high-grade polymer. Hip replacements are proven, successful operations that improve the quality of life for patients.

Knee replacement

Is a surgical procedure in which the damaged or worn parts of the knee are removedandreplacedwithanartificial

joint containing metal and highgrade polymer. It's a very successful operation for the vast majority of patients.

Partial knee replacement

Is a surgical procedure in which just the damaged or worn portions of the knee are removed and replaced with a new partial artificial implant made out of metal and high-grade polymer. The advantage of this operation over a total knee replacement is the preservation of all ligaments and normal joint surfaces

resulting in a knee that's biomechanically more normal. Other benefits of this operation are a smaller incision, less blood loss, a shorter time spent in hospital and a quicker recovery period.

Knee arthroscopy

Is a keyhole procedure most commonly performed for cartilage (meniscal) tears, loose bodies and cartilage defects due to early arthritis. The arthroscope contains optic fibres that transmit an image of your knee through a small camera to a computer monitor. This image allows Mr Cohen to thoroughly examine the inside of your instruments
